

BRIEF NOTE ON COMMON ENVIRONMENT INFRASTRUCTURE SUBSIDY-2020

OPERATIVE PERIOD OF POLICY

01.09.2020 to 06.08.2025

ELIGIBLE INDUSTRIES:

New as well as Expansion undertakings are eligible for incentives.

-Any Industries association / Any Enterprise (except for captive use) or firm which is registered under Societies Act, Trust Act or under the Companies Act.; or GIDC/Board/ Corporations/ SPV/ PSU/ Municipal Corporation/ Nagarpalika/ Urban Development Authority etc.is eligible to apply.

For your case, Pet bottle recycling using indigenous waste.

ELIGIBLE FIXED CAPITAL INVESTMENT

- 1. New Building-New construction (Building cost shall be SOR rate/CE Certificate or Actual cost whichever is lower)
- 2. Plant and Machineries: New Machineries & Utilities
- 3. Any other Capital Exp. Of CEI As approved by SLEC

INELIGIBLE INVESTMENTS

- The Project availing incentives under this scheme will not be entitled to avail incentives under any other scheme of the State Government for the same component, unless specified otherwise. However, the project will be eligible to avail incentives available under schemes of Government of India or any other institutions.
- The following investments are not eligible for financial assistance:
- 1. Land purchase
- 2. Land development
- 3. Preliminary expenses
- 4. Pre-operative expenses
- 5. Consultancy fees
- 6. Effluent Treatment plant
- 7. Any Cost Incurred before application under this policy
- 8. Any Indigenous capex without following guideline of GR
